Our annual Fire and Life Safety Conference will be held in March next year. However, due to rising concerns about the Corona virus, and waiting as long as we could, we chose to cancel the in-person event to do a virtual conference.

We know that sitting at a computer for most of day is difficult, so we are only going to do three-hour sessions. The "conference" will be Monday – Friday. We will start at 0900 to allow you to answer phone calls and emails prior to the sessions, and end a noon so you can conduct your routine business for the remaining day. The plan will be a general session on Monday, followed by two days of Fire and Life Safety programs, and that will be followed by two days of code enforcement programs.

The topics for the conference will be What's the Big Deal About CRR?, Motivating for Behavior Change – Why Don't People Do What We Want Them To Do?, Effective Social Media, Vision 20/20 and IL Model, Solar Plan Review, Fire Pumps, Flammable Refrigerants, and Update to NFPA 72.

The dates of the conference will be March 22 - 26, 2021. We will have three pricings. One for the full event – Best Value, a three-day code *or* FLSE fee, and a daily fee. The three-day fee

would be best for educators who might no have the need for code enforcements topics. Mark this down now and plan to attend.

For those that had rolled the registration into 2021, thank you. We will refund you the difference from last year to what you choose for 2021. Stay tuned for more details as they develop. A Save the Date with much more information will be out very soon.
