

With fire department open houses beginning soon, many departments use a burn door prop to show the benefits of a closed door. If you have one of these props, consider adding some graphics to it – there are many good talking points on them. There is a company in Roselle, GZ Sign Designs, that has made two full length graphics. Their phone number is (630) 307-7446. Ask about the fire door stickers. The cost is minimal, and instead of the Fire Services name they can easily change it to your organization. These graphics have been added to the door prop used at the State Fair, as seen in these pictures. The graphics will allow you many more "visual" talking points.

While the graphics are "designed" for a 36" door, they are easily trimmed down to fit a 34" one.
