Not Doing Your Job

A lawsuit is taking place in Schenectady County, NY, due to a fire inspector not doing his job properly. This case involves a fire alarm inspector who failed to do his job and ensure proper compliance with a fire alarm system that protected an apartment building. The day after he "passed" the fire alarm system through an inspection, there was a fire that claimed four (4) people's lives. This could have been avoided if he did his due diligence and failed the fire alarm system as it was not up to code. Instead, this individual decided to cut corners and negligently pass the fire alarm system. If convicted, this individual could face up to (15) years in prison. An attachment gives the full story.

Our February mini seminar on the Existing Building Code, presented by Rich Piccolo, was a big hit. Once again we were at Top Golf for the seminar and everyone enjoyed the fun following the class. A big thank you to Fran Lundin and Craig Studer for their effort to bring education and recreation together.

There is some active legislation regarding legalizing fireworks. The IFIA is opposed to the concept of 1.3 rated fireworks being sold to the consumer in Illinois. As things progress, we will keep you informed. Stay tuned, as we may have to ask for your assistance in opposing this.

Given the rise in school shootings, there has been much discussion on what can or should be done. The Colorado Division of Fire Prevention & Control has provided guidance to school districts and local fire authorities. This guidance was developed in concert with their sister law enforcement agencies. This is good common sense advice that you may want to pass on to your educational facilities. In essence, schools are advised that:

- If there is no known threat, students and staff should immediately evacuate as normal upon the activation of a fire alarm.
- If there is a threat (l.e. lockdown or lockout), students and staff should either remain in lockdown and delay evacuation until it can be determined whether a fire exists.
- Staff are advised to remain alert and should be empowered to adjust their responses based upon the conditions they encounter. For example, if under lockdown they smell smoke or are otherwise threatened by fire, they should react to the greater perceived threat. Also, if a bad actor is in one wing of a school, administrators may be able to advise staff in other wings to evacuate. On the other hand, if evacuating they notice in the corridor a student who has been expelled or anything else that concerns them, they should consider delaying evacuation. Many schools now teach staff to look into corridors before sending their kids out. In the past, standard practice was to send the kids first.
- Individual staff empowerment is key. Teachers are well-educated and most can be counted on to act in a sensible manner if given the leeway to do so. We are in an age where cookie cutter responses to emergencies are no longer going to work.
