The certification classes are going well this year. Our Fire Inspector 2 class which is going on now has 12 students registered. Also, for the first time, we are partnering with the Romeoville Fire Academy to offer classes. We will begin this with Fire Inspector 1 in January.

The Fire and Life Safety Educator class will be offered in May of 2021 at Downers Grove.
