# A Message from the Board of Directors

A reminder for those with ICC certifications, as mentioned at last month's meeting, the ICC has approved us for issuing Preferred Provider CEUs for our classes, and the Fire and Life Safety Conference. Remember that if you have an ICC certification you are required to get 50% of your con ed points through preferred provider classes.

We are planning for the future and are looking to expand our instructor base for the Fire Inspector 1 and 2 classes. These are the classes that are needed to obtain certifications from the OSFM. A clarification from the ICC regarding Fire Inspector 1 and the "challenging" the ICC Inspector certification. In order to obtain the ICC certification, if you have a Fire Inspector certificate it must also be a Pro Board certification. You will only have this year to do this, as they will not be offering this option in 2020.

NOTICE: There is a door barricade company that is stating in their advertising that "The Illinois State Senate passed a bill in early April that will allow schools to add barricades to classroom doors, making it the fourth state in the Midwest to allow barricades, for an extra measure to help ensure student safety." That statement is not completely accurate. The Senate has passed that bill, but it still NOT law. It still must be passed by the House and signed by the Governor. The OSFM is against this as it now stands. When this gets introduced into the House the IFIA will be working with the OSFM for language that would be acceptable, including that the device must be approved by the local AHJ. We will keep you updated on this as it progresses.

Save the dates! For those looking for OSFM Inspector 1 and/or 2 classes, they will be held this fall in New Lenox. Inspector 1 will be August 1, 8, 15, 22, 29, and Inspector 2 will be October 1, 8, 15, 22, 29. Check the website or contact the office to register.


