Our big annual event, the Combined Conference is almost upon us. The preconference flyer showing the topics and descriptions is attached. There are two times of importance for you to be aware of. The first is early bird discounts for registration. **That will increase on March 15<sup>th</sup>**. The second is hotel registration. Our special block of rooms ends on **April 5<sup>th</sup>**. Please support 10 year smoke detector batteries. Senate bill 2837 is proposed to amend the smoke detector act. It will require smoke alarms to have batteries of a minimum of 10 years, and the battery must be non-replaceable and non-removable. There is a hearing on March 8<sup>th</sup> in Springfield on this bill. We encourage you to support it. Please file witness slips in support of this bill.
