The big items the Board has been dealing with has been with legislation and our Annual Conference. By the time you read this our Conference has concluded and we feel we can safely say that it was our best event yet. There was also a lot of hard work from the Codes Committee, Fire and Life Safety Committee, and the Conference Committee. At this conference, two awards were given out. The Lonnie Jackson award for outstanding work in the FLSE field was given to Bill Proper of Tinley Park. The second was to Rich Piccolo for over thirty-five years of service to the IFIA on the Codes committee. Rich decided that last December was going to be his last year serving on that committee and on the Board. He will continue to be seen teaching a class or two over the years.

On the legislative front, the General Assembly was on spring break for two weeks. Prior to that, the IFIA testified on Senate Bill 1685, which is our initiative for minimum qualifications for fire alarm designers, installers, and testers. The testimony was for Subject Matter only. Basically that means it was not officially called for a hearing, but information was read into the record. After the testimony, several organizations contacted us to discuss the Bill. Discussions with those organizations are ongoing, and while the Bill has stalled, we are hopeful that after discussions, negotiations, and retooling that we will reintroduce an even better Bill. We feel confident, as the agencies agreed in concept to what we were doing, but had some differences of opinions on some of the language. As always, we will keep everyone posted.

June 10th will be the 1st IFIA/IL-AFAA combined Golf Outing to be held at White Pines Golf Course in Bensenville. Registration is open now, so please register early, and often.
